Selectmen's meeting minutes November 16, 2010

Attendance- Bob Drew, Turf Ramsden, and Stephen Goldsmith. Larry Fox, Gene Spender, and Scott Gardiner were also present.

1. Turf made the motion to accept the minutes from last week, Bob seconded it and all voted in favor.
2. We met with the LIPPC. Those present were: Gerry Nelson, Gene Spender, Tom Hughes, Ed Nista, Ann Williams, and Trip Turner. We had a long discussion about how the Selectman would like this committee to be run. It was decided that there would be monthly meetings, minutes would be taken and at an annual meeting officers (Chairman, vice chair, etc) would be elected. The meeting would be run following Roberts Rules.
Bob made a motion to notify all present members of LIPPC and have them come to another meeting to discuss what we had decided. This motion was not seconded. Steve then made a motion to have a meeting with the current LIPPC members as well as the following: Ed Poliquin, Ralph Tedesco, Ed Nista, Dave Mills, Anna Romer, Colin Micklon, Lucy LaCasse, Ray Senecal, Diane Caraccioli, and Sue Hamlin, to attend a meeting on Monday November 29th at the Town Office beginning at 7:00 to discuss a plan for going forward and to have Gerry Nelson chair this meeting if possible. Bob would be the chair if Gerry cannot attend. Turf seconded this motion. The vote was 2 for and 1 against. Bob will notify all LIPPC members, Tom Hughes will notify those from KLWA and Gene will notify those from GLLT.
3. We signed the warrant.
4. Read a request from Reach requesting \$500.00 for next years Town meeting
5. Read a letter from Lovell Old Homes Day requesting \$2,500.00 for next year.
6. We read the October student enrollment list for the district.
7. We read a public notice about an upcoming Planning Board meeting.
8. We read the Lovell Recreation minutes.
9. We saw a detailed list of the Lovell Recreation director's mileage and hours.
10. We read a report from Mid Maine Waste and when their next meeting will be.
11. We discussed vacation and sick leave and what account(s) that should come out of.

12. We discussed an order with the well and Larry is aware of this and he will investigate it.
13. Larry will be hiring a part-time temporary worker to help out while Fran is out on leave. We will pay this person \$13.00/hour and will limit him to 40 hours per week.
14. Larry is working with Scott Davidson so that he might be able to drive and plow with the one-ton should we need his help.
15. Gene spoke about the GLLT and the current wording of the easement with the Prescott land. We will try to communicate better in the future to avoid these problems.
